**11 / 2022 - 01 | Welcome**

Chairman welcomed Cllrs and members of the public.

**11 / 2022 – 02 | Apologies for absence**

Cllr Daniels sent apologies.

**11 / 2022 - 03 | Declarations of Interest**

Cllr Browne noted she works for Essex County Council.

**11 / 2022 – 04 | To agree the minutes of the last meeting (16<sup>th</sup> August 2022)**

**Resolved:** That the minutes be agreed as a true record. Proposed Cllr Day, Seconded Cllr Offord - all in favour.

**11 / 2022 – 05 | Chairman’s Report**

The village hall group has met now on more than one occasion. We need a storage facility which quotes have been sought for.

A review of the hirers of the hall has found that some user groups are not paying for the time spent in the hall, the post master is lacking support from the post office and we are reluctant to increase the fees for such a valuable community service.

At a meeting of the village hall committee, it was agreed that £8 an hour hire fees would mean break even. We have been contacted by an outside business who offered £80 a day for the hire fee but as it currently stands, we are unable to accommodate this booking.

**11 / 2022 – 06 | Clerks report / correspondence**

Ongoing discussions with Lambert Smith Hampton about the approval for the installation. Section 106 funds have been approved.

It was agreed that we should let the play company know that we wish to proceed with the project. Proposed Cllr Day, Seconded Cllr Bush - all in favour.

**11 / 2022 – 07 | District Councillor Report**

Cllr Bush gave an update on the following matters:

The economic situation, energy costs, getting on the housing ladder. A recent member briefing at TDC imparted some knowledge for services for those in need. CCIC was setup during COVID and was

successful in the village and beyond into neighbouring villages. This can be used once more and has been renamed GLOW – Great Little Oakey and Wix. There is some money in the pot and this can be used to support anyone in need.

TDC have an allocation of houses that need to be built each year and the sway in the interest rates and general market feeling could cause a problem for buyers in the coming years.

The Conservation area character appraisal is underway within TDC and Great Oakley is in scope, there is a large document about the village and TDC is looking for feedback from local people. There will be an open event in the village for people to attend.

Remembrance Sunday is close and has there been any interaction with the church?

TDC have partnered with other local authorities to bring forward Freeport East – each partner will give £80k for two years to the vehicle.

### **11 / 2022– 08 | County Councillor Report**

The Full Council met and discussed about the measures in place to support people during the current financial situation. Have asked for a list of all protected trees in the village.

### **11 / 2022 – 09 | Reports**

#### **Burial Ground, Recreation Field, Play Area and Greenswards**

Cllr Nice reported that there had been some damage to a tree near the entrance on School Road. A second visit proved that there is some laying wood that may need to be cleared. Could another dog bin be sited nearer to the entrance. Other areas have bins that have poo bags attached to them. Could the signs be looked at as they seem to have disappeared.

**ACTION:** get a quote for these types of bins, including emptying.

**ACTION:** ask TDC about no dogs in the play area signs.

**ACTION:** find a footpath map for the telephone box and notice boards

**ACTION:** place the footpath map onto the website

#### **Public Rights of Way / Footpaths**

Cllr Browne continues to monitor the paths as well as the bins in the graveyard.

#### **Great Oakley and Stones Green in Bloom and Queen's Jubilee**

Cllr Daniels is working on things in the background – diligently as ever!

#### **Village Hall**

Meeting taken place with the working group and there has been progress on maintenance and operational matters.

**Resolved:** that £499 be spent on a new storage facility for the hall which will be placed outside. **Proposed that a finance meeting takes place, then a decision is made on this.**
